

Sub : Display of Notice on 5.03.2021 in the website regarding Recruitment to the post of Asst. Driller (T) and Jr. Sc. Asst. Gr.II.

List of eligible / not eligible candidates for the post of Asst. Driller (T) & Jr. Sc. Asst. Gr.II was earlier displayed in our website.

Cases of "Not Eligible" candidates due to non-payment of Examination Fee has been considered and it was found that though DUD Number of Bank generated but money has automatically been refunded in the Account of candidates and in rest of the cases finally payment has not been received by CMPDI. Accordingly, following is displayed for information of all concerned :

Jr. Scientific Assistant Gr.II :

- i) Ex. Serviceman is exempted group. Hence, name of 08 ESM appearing in "List of Not Eligible Candidates" for the post of Jr. Sc. Asst. Gr.II have been placed in "List of Eligible Candidates" at **Annexure-A**.
- ii) Qualification of B. Tech., BE, B Pharma etc. have not been found eligible for the post of Jr. Sc. Asst. Gr.II. This includes BE/B.TECH in CS/IT etc. also. Candidates having such qualification will not be allowed to appear in the Written Test. If by mistake, name of such candidates is appearing in the Eligible List earlier displayed, is hereby cancelled.
- iii) 186 candidates whose name is appearing in "List of Not Eligible Candidates for the post of JSA" due to non-payment of Examination Fee are hereby allowed to make payment of Examination Fee through SBI Collect, as done earlier, within 07 (6.3.21 to 12.3.21 till 5.00PM) days from the date of display of Notice in Website. "List of Such Eligible Candidates" is at **Annexure-B**.

Assistant Driller (Trainee) :

- iv) 249 candidates whose name is appearing in "List of Not Eligible Candidates AD" due to non-payment of Examination Fee are hereby allowed to make payment of Examination Fee through SBI Collect, as done earlier, within 07 days from the date of display of Notice in Website i.e. within 6.3.2021 to 12.3.2021 (5.00PM) "List of Such Eligible Candidates" as appearing in **Annexure-H** of our earlier display of Notice.
