Subject : Regarding waiving of mailing hardcopy of application/certificates etc


This is issued in reference to our Employment Notice vide No. CMPDI/HQ/SE/R/19-20/E-445469 dated 11.02.2020, published in the Employment News (29th February to 6th March '2020 edition), for filling up statutory vacancies for the post of Dy. Surveyor (Mines) & backlog vacancies for the post of Stenographer (Eng.) through direct recruitment and regarding mailing of hardcopy of application/certificates etc.

In this connection, we have received only a few number of hardcopy of applications/certificates till date against the employment notice mentioned above. However, a considerable number of candidates have requested to extend the last date of receipt of mailing of the hardcopy in view of the nationwide lockdown announced by the Government of India for controlling the spread of COVID-19.

The same has been discussed and CMPDI Management, considering the overall prevailing situation in the country, has decided following points:

- To waive off mailing of hardcopy of application/certificates etc (mentioned in Pt. 5.10.3 /Annexure-I of our notice referred above);
- Scrutinize the eligibility of the candidates for Written Tests solely based on the information provided by the candidates in the online application form. i.e. no candidates are required to send hardcopy of the application/documents etc to CMPDI.
- In case of **PwBD candidates requiring special assistance / Scribe for the Written Test** with regard to the candidate's area of disability with disabilities of 40% (Forty percent) or above, it has been decided to allow these candidates to make such requests till **30.04.2020 (Thursday)**. Such requests with scan copy of **filled-in Appendix-I & Appendix-II** (of Annexure-II of our Employment Notice) should be mailed to **cmpdi.recruitment@coalindia.in**. In Appendix-II of Annexure-II, name of the post & Application No. is to be written in place of name of examination & Roll No. respectively.
- The list of eligible/ineligible candidates for the Written Test will be published at CMPDI Website shortly and candidates will be allowed to point out their individual grievances, if any, **within 10 days for its redressal**. After expiration of 10 days, no representation in this regard will be entertained.

All candidates are requested to visit our CMPDI website **www.cmpdi.co.in** for notification of modalities/schedule/date/venue etc of the examination. Apart from our website, no other mode of communication/media will be used for the same.
